Direct Award Process

A direct award to the number 1 ranked Service Provider on our frameworks will take approximately 3-4 weeks depending on internal approval processes.



Mini Tender Process

This process enables you to use your own specification and cost model. You can also choose your own cost/quality split and quality questions. The tender process takes approximately 6-8 weeks, depending on your internal approval processes.
